Core Purpose	<ul> <li>Under the reasonable direction of the Headteacher, carry out the professional duties of a school teacher as set out in the current School Teachers' Pay and Conditions Document (STPCD)</li> <li>To implement and deliver an appropriately broad, balanced relevant and differentiated curriculum for students and to support a designated area as appropriate</li> <li>To monitor and support the overall progress and development of students as a Teacher/Form Tutor</li> <li>To facilitate and encourage a learning experience which provides students with the opportunity to achieve their individual potential</li> <li>To contribute to raising standards of student attainment</li> <li>To share and support the school's responsibility to provide and monitor opportunities for personal and academic growth.</li> </ul>
